FIDELITY CARD OLD WILD WEST MONTECARLO

FIDELITY CARD OLD WILD WEST MONTECARLO is the loyalty card (hereafter, the CARD) that allows you to access discounts and advantages at the restaurant operating under the sign OLD WILD WEST and located in Montecarlo.

The loyalty program referred to in the CARD is governed by this regulation, which is read and accepted in all its parts by the Customers, at the time of accession itself.

PROMOTER: the promoter of this initiative is the company EXPLORER'S s.à.r.l. based in Montecarlo (Monaco) at the Route de la Piscine - Darse Sud du Port - Quai Albert 1er - 98000 Monaco, VAT FR53000090547 (hereinafter "Promoter") Monegasque law company, owner of the restaurant participating in this activity as identified below.

AREA: the CARD allows you to benefit from discounts and benefits only at the issuer restaurant OLD WILD WEST located on Monaco's national territory at 30 Rte de la Piscine, 98000 Monaco.

RECIPIENTS: All natural person, adults, customers of participating restaurants, excluding the owners, their members, employees, and any collaborators of the Promoter can acquire and use the CARD in an absolutely free form.

ISSUE: the CARD will show the indication of the restaurant from which it will be issued and will be available only at the same point of sale. The Promoter is not responsible for any loss or damage to the CARD. Lost or damaged CARDS cannot be replaced. Even if the CARD is not registered, there is only one active CARD per customer and the use of the CARD must therefore be strictly personal and not transferable.

USE: During the period of validity of this activity, customers holding the CARD will have 1 (one) point recognized for every 25,00 (twenty-five/00) Euros of expenditure for consumption directly at the participating restaurant, or by take away with payment in the restaurant. The latter will mark each point acquired with a special stamp on the CARD. Points can also be accumulated on the CARD compared to the promotional menus.

The customer who holds the CARD can accumulate points only on drinks for a maximum of 5 people.

Upon reaching one of the premium thresholds indicated below, the customer who holds the CARD will be entitled to receive a discount voucher that can be spent on the next consumption by delivering the card at the cashier at the restaurant where it was issued.

- every 10 (ten/00) points = discount voucher of Euros 25,00 (twenty-five/00)
- every 15 (fifteen/00) points = discount voucher of Euros 40,00 (forty/00)

Once the prize is used, the card will be collected from the restaurant.

The prize discounts are usable every day, will not be convertible into money, will not be cumulative with each other, will not be entitled to change and cannot be used on menus or promotional items (e.g., Lunch Menu). The premium discounts are also available for take away with payment in the restaurant.

It is understood that upon reaching the threshold of 15 points the CARD will no longer be usable and the participating restaurant will deliver a new CARD in a totally free form to the customer.

In the event that the restaurant member finds a fraudulent or otherwise incorrect use of the CARD, they may cancel it, without any notice, canceling and requesting the return of any advantages unlawfully acquired. The Promoter is entitled to take any legal action against the holders of the CARD.

EXPIRY AND VALIDITY: the CARD is valid until 31/12/2024. The discount vouchers obtained can be used until 31/01/2025.
